The Contractor and Supplier registration is being presently carried out through MP Online as per circular no.3427 dated 11.10.2018. In continuation to the above the renewal charges for Contractor and Supplier registration is as under:

➤ **Charges:-**

1. MP Online Kiosk charges – Rs.500/-
2. Renewal of A class Electrical contractor registration charges- Rs.1000/- + GST.
3. Renewal of B class Electrical contractor registration charges- Rs.500/- + GST.
4. Renewal of supplier registration charges- Rs.500/- + GST

➤ **Validity of registration after renewal:-**

1. A-Class Electrical Contractor– Three years from date of renewal of registration or validity of license whichever is earlier.
2. B-Class Electrical Contractor - Three years from date of renewal of registration or validity of license whichever is earlier.
3. Supplier - Three years from date of renewal of registration.
